The services main aims:

- Home, school and community support for children, young people and their families through a referral pathway. One to one support for children affected by parental offending in schools to explore their thoughts and feelings.
- Partnership working with agencies and organisations across Essex including Health, Education and Social Care, HMP&YOI Chelmsford and other prisons, Court Services and Community Rehabilitation Companies (Probation teams).
- Induction talks for detainees and satellite support for their families in the UK. Family day events and services provided at the Colchester Military Correction Training Centre (MCTC).
- Training courses and workshops for professionals including Hidden Sentence Training.
- Multi Agency Steering Group meetings for professionals to discuss local needs and issues affecting children, young people and their families, local and national data and opportunities for joint working.
- Establishment of Single Point of Contact (SPOC) leads across Essex to provide a network of advice and local knowledge and support for professionals and families to access.

<p>Missing Education &amp; Child Employment Service</p> <p>Child Missing Education</p>	<p>Schools, including Academies and Free Schools are required to inform the LA (under The Education (Pupil Registration) (England) Regulations, 2006) of the details of pupils who have been absent from school for 10 continuous school days and contact cannot be made with the parent/carer to establish the reason for the absence and the absence has not been reported. <p><b>Child Employment</b></p>	<p>The law relating to child employment allows for young people aged 13 and above to take on part time employment. Any young person who assists in a trade or occupation for profit is considered as employed, even if they receive no payment. For example, children who help their parents in a shop without receiving payment are still considered to be employed.</p> <p>Application has to be made for such employment to Essex County Council and a free permit granted. It's the employers' responsibility to apply, not the child. There is no cost.</p> <p>The local authority may revoke a child's employment permit if the authority thinks that the child is undertaking illegal tasks or the child's health, welfare <u>or education</u> is likely to suffer.</p> <p><b>Full-time work</b></p> <p>No child or young person of compulsory school age is eligible for full time work. Where a young person wishes to engage in full time work, they must first reach <a href="#">minimum school leaving age</a>. (Last Friday in June of Year 11).</p> <p><b>Restrictions upon when and where children and young people are eligible to work</b></p> <p>There are several restrictions on when and where children are allowed to work.</p> <p>Children are <b>not allowed</b> to work:</p> <ul style="list-style-type: none"> <li>• without an employment permit issued by the education department (this role is fulfilled by the Missing Education and Child Employment Service for children and young people within Essex)</li> <li>• in places like a factory or industrial site</li> <li>• during school hours</li> </ul>	<p><b>MEMBERS OF THE PUBLIC ARE TO REPORT ANY CHILDREN OF SCHOOL AGE WORKING ILLEGALLY TO THE CENTRAL CHILD EMPLOYMENT &amp; ENTERTAINMENT TEAM</b></p> <p><b>Tel: 0333 013 8967 or email <a href="mailto:child.employment@essex.gov.uk">child.employment@essex.gov.uk</a></b></p>

- before 7am or after 7pm
- for more than one hour before school
- for more than 4 hours without taking a break of at least 1 hour
- in most jobs in pubs and betting shops in any work that may be harmful to their health, well-being or education
- without having a 2-week break from any work during the school holidays in each calendar year

**Examples of permitted employment:**

Light agricultural/horticultural  
 Delivering newspapers  
 Hairdressing - general duties  
 Office  
 Café/restaurant - waiting tables/general duties  
 Riding stables  
 Domestic hotel duties  
 Shop work - general duties

**Examples of prohibited employment:**

Cinema, night club, disco  
 Street trading  
 Commercial kitchen preparing or cooking food  
 Fairground/amusement arcade or skittle alley  
 Collecting money or selling/canvassing door to door  
 Slaughter house  
 Industrial, construction or manufacturing industries  
 Selling or delivering alcohol  
 Collecting/sorting rubbish  
 Delivering milk or fuel  
 Using dangerous machinery  
 Telephone sales  
 Personal care of residents in care/nursing homes  
 Exposure to biological or chemical agents  
 Anything that is three metres or more above ground level  
 Anything that involves exposure to adult material  
 Anything that involves heavy lifting

**There are also special rules which only apply during term times and school holidays.**

**Term time/school holiday rules relating to child employment**

During **term time** children can only work a maximum of 12 hours a week. This includes:

- a maximum of 2 hours on school days and Sundays
- a maximum of 5 hours on Saturdays for 13 to 14-year-olds, or 8 hours for 15 to 16-year-olds

During **school holidays 13 to 14-year-olds** are only allowed to work a maximum of 25 hours a week. This includes:

- a maximum of 5 hours on weekdays and Saturdays
- a maximum of 2 hours on Sunday

During **school holidays 15 to 16-year-olds** can only work a maximum of 35 hours a week. This includes:

- a maximum of 8 hours on weekdays and Saturdays
- a maximum of 2 hours on Sunday

**Entertainment Licensing :**

MECES responsible on behalf of Local Authority to issue the Licenses for children performing in shows, pantomimes, films etc. and for issuing the Essex Chaperone Licenses for those supervising the children.

The performance / rehearsals cannot impact on child's education - if so then then performance Licenses could be revoked> Productions can be stopped, if Production Manager / Team do not comply with the law.
